For this month's meeting agenda, HCMPO Staff has been working on revising the functional classification of our roadways in the metropolitan area of Hidalgo County. After its approval in the month of April, we received a request from the City of Mercedes and TxDOT's comments resulting from their review. We have revised the functional classification map to reflect the additional changes, and it is on our ftp (www.hcmpto.org/webfiles) site ready for you to download and review your respective areas before the TAC meeting next week since Staff is seeking your approval. In addition, it is time to begin the process for the 5th Annual Border to Border Transportation Conference for next year. We have acquired three quotes from the McAllen Convention Center, Isla Grand from South Padre Island, and from Yuma, Arizona. We are seeking your recommendation as to where you would like for the conference to be held.

As discussion items, the MTP and TIP amendments will be beginning the public involvement period, and you will see these items in the October TAC Agenda seeking approval. The public workshops have been completed for the Pedestrian Plan, and HCMPO Staff is planning on providing you with those results.
